⁵ Family rate: Maximum two parents or guardians accompanying their dependent children under 19 years of age.

⁶ Post-secondary school students with a current provincially recognized post-secondary school student card pay the student drop-in rate for admission to Leisure Services facilities; if proof of fulltime status is provided they pay the student rate for economy tickets and memberships.

⁷ For a challenged person who is <5 years old, the assistant / parent / caregiver pays admission at the child drop-in rate (subsidies apply).
