Recommendation:

Action: Council consider comments regarding disposition of land to LNG Canada for their use of a portion of District Lot 471 to re-enter the southern salt marshes and undertake corrective actions to reestablish the plants in the area.

Recommended Motion:

To be determined from the options below.

Background:

LNG Canada (LNGC) constructed salt marshes in Minette Bay as part of their fisheries offsets. In 2018, the District of Kitimat (DOK) granted lease and licence agreements (refined in 2019) allowing access for three years for construction purposes with a licence agreement for ten years for monitoring after construction is complete.

The 2018 Lease Agreement included exclusive access to and use of roads and the lay down area developed for LNGC salt marsh construction. Road maintenance and snow clearing was the responsibility of LNGC, and a lease payment of \$150,000 and road restoration payment or other ecological work of \$350,000 paid to the DOK. Options include full restoration or another solution that may leave some of the disturbed area for public use and new amenities.

The road use and access Licence Agreement between LNGC and the DOK allows for non-exclusive access for LNGC to monitor the salt marsh following construction. The term of the licence was ten years following construction, plus annual renewals for up to ten years if access is still required. Vehicle access is restricted to use of DL 471, with access to DL 95 only by water or as pedestrians. LNGC assumed responsibility for snow clearing and road damage repairs, and an annual licence fee of \$1,000 plus tax, and recovery of any associated legal fees.

LNGC completed the salt marsh construction from 2019 – 2022, and the first three years of monitoring was completed 2021 – 2023. LNG Canada is aware of deficiencies in this project and is required to do remedial work to the salt marsh area. Accordingly, they have approached the District to again use a portion of DL 471, using the existing roads and lay down area.

On March 20, 2025, the District issued public notice of our intention to dispose of a portion of DL 471. A copy of the public notice is attached for reference (Attachment A).

During the comment period, a comment was received by Vivian Moon who resides immediately adjacent to DL 471. The comment is provided for Council consideration (Attachment B).

LNGC has met with the property owner and provided a summary of their actions and proposed mitigations for the salt marsh project (Attachment C).

Options: Staff is seeking direction from Council on disposing (licence and lease) of the land to LNGC and offers the following for Council consideration:

1. If Council wishes to approve disposing of the land for the term, the following is offered for Council consideration:

THAT the Mayor and Corporate Officer be authorized to enter into the road use and licence and lease agreement with LNG Canada Development Inc. as described in the District's Public Notice issued March 20, 2025.

2. If Council wishes to dispose of the land over the term with recommendations to LNG Canada on meeting with and mitigation with this property owner:

THAT the Mayor and Corporate Officer be authorized to enter into the road use and licence and lease agreement with LNG Canada Development Inc. as described in the District's Public Notice issued March 20, 2025.

AND THAT LNG Canada Development Inc. be requested to meet and work with the property owner on mitigation measures during the duration of the construction project.

3. If Council does not wish to dispose of the land to LNG Canada:

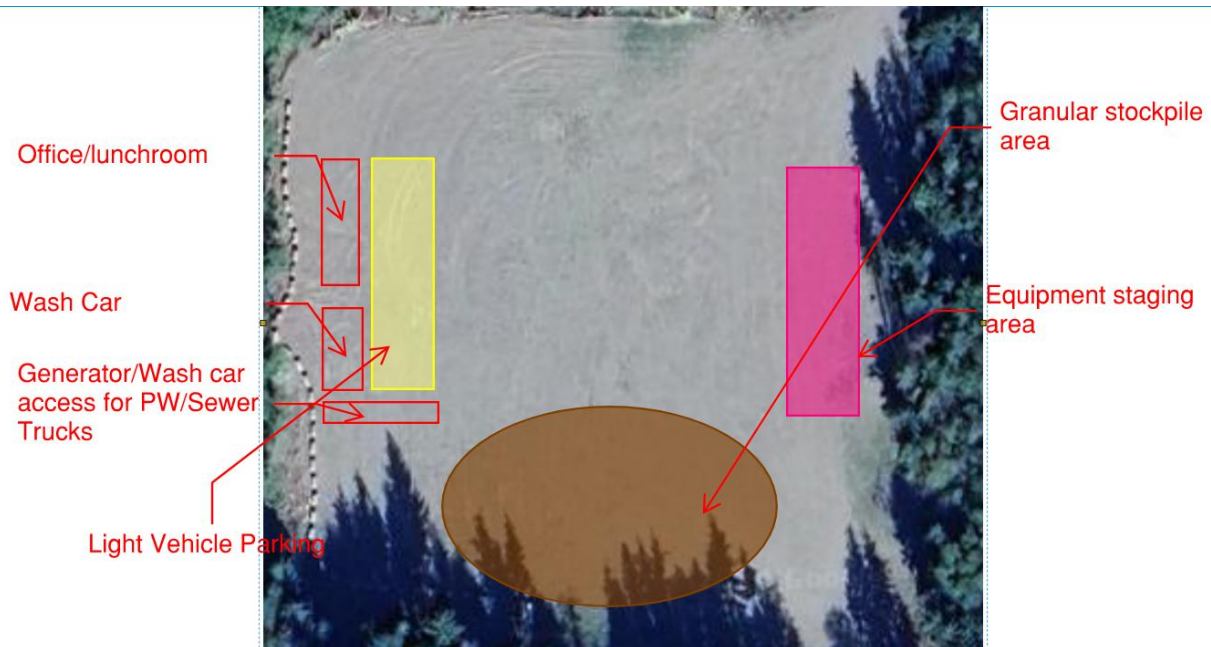
THAT the District of Kitimat does not enter into the road use and licence and lease agreement with LNG Canada Development Inc. for use of District Lot 471.

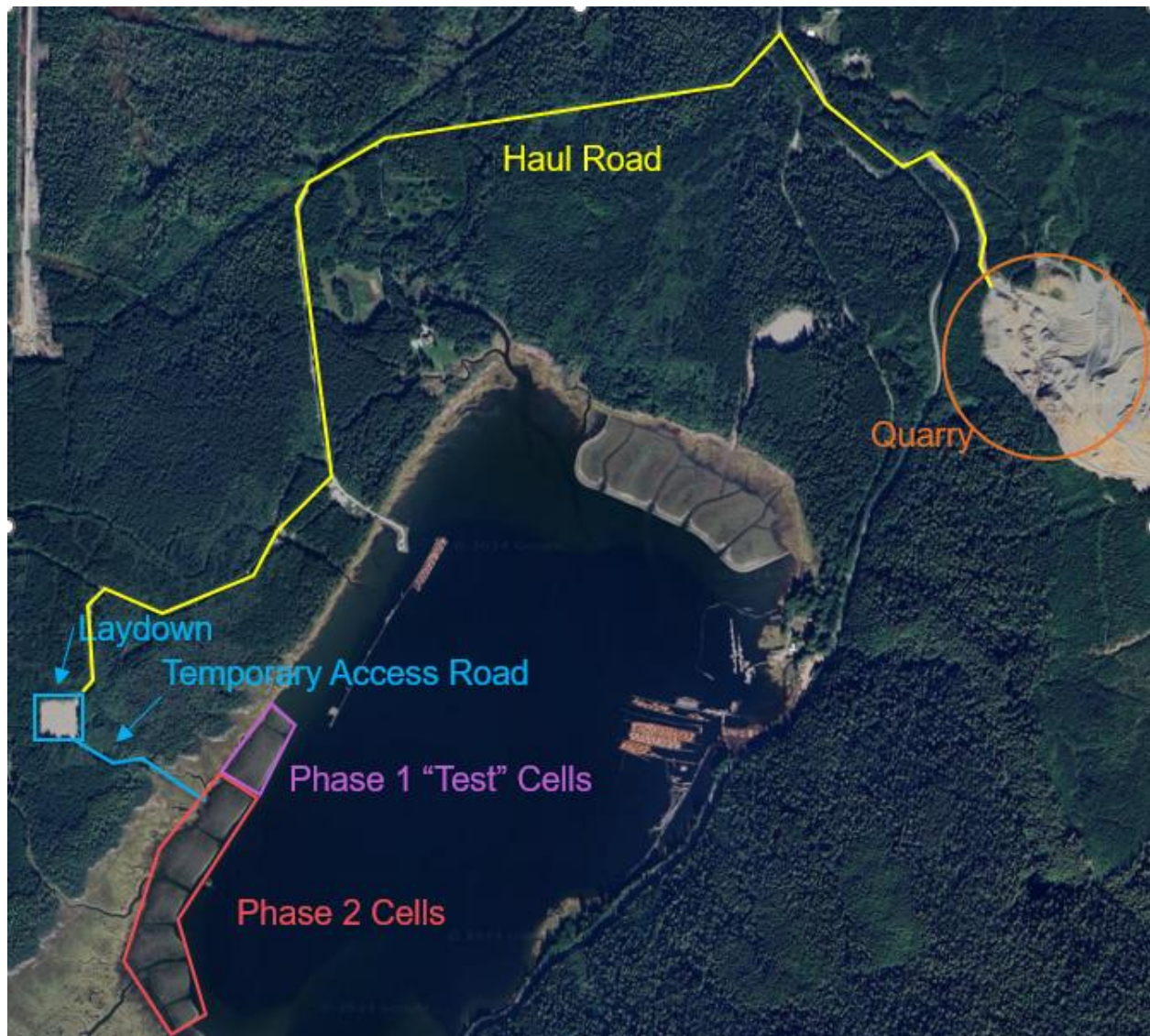
If this is the direction LNG Canada will be required to obtain alternative access to the salt marsh area.

Public Notice

Section 26 of the *Community Charter* requires public notice when disposing of interest in Municipal Property; this is applicable to the amended Lease. The Public Notice describes the property, a description of land and improvements, the nature and term of the proposed disposition, and consideration received. The public was provided at least 10 days to respond after the notice was posted. Section 94.2 of the *Community Charter* requires that notices are published for two consecutive weeks on Facebook and Get Involved Kitimat as well as the usual public notice places. The notice was also published in the local newspaper.

Area to be used by LNGC: The space for the Laydown area is similar to the previous use when the salt marsh was constructed:

The large open area has not yet been restored to nature as it provides another possible access to the water and in the future Council can decide on whether it remains in its current state or is replanted.

LNG Canada Lease & License to Access Minette Bay West

LESSEE AND LICENSEE	SUBJECT PROPERTY:
LNG Canada Development Inc. on behalf of itself and as agent for the Participants (Shell Canada Energy, North Montney LNG Limited Partnership, Diamond LNG Canada Partnership, PetroChina Kitimat LNG Partnership, and KOGAS Canada LNG Partnership)	Minette Bay West (District Lots 471 and 95, Range 5 Coast District)

Notice of proposed disposition is given in accordance with section 26(3) of the *Community Charter* for a Lease that would provide exclusive access and use of construction site and laydown area portions of DL 471 (see red area on Map below) during supplemental work for salt marsh (re)construction. Proposed term is three years less a day. Consideration for this (second) term includes:

- i. Lease payment of \$150,000 for land use and access to water;
- ii. Snow clearing and road maintenance on DL471 and access route from Kitimaat Village Road outside of DL471; and
- iii. Other consideration, including recovery of legal expenses.

The corresponding Licence that was approved in 2018, and became effective in 2021 already provides non-exclusive access over DL 95 and DL 471 to monitor salt marsh performance for a term of ten years, plus up to ten one-year renewals thereafter. It is also being amended to attach the amended and restated Lease and update LNGC company information, the Participants and notice particulars.

When they last did this I couldn't get away from the noise & vibration. I would retreat to the other side of the house only to be hit with the LNG pile driving banging away. Once I was awoken at 6 am & checked my phone to see if there was an earthquake!

I wasn't notified in 2018 when this first started with falling trees even though my door is only steps away. I confronted Ledcor (the prime contractor) who just passed me off to someone who failed to inform LNG Canada of my complaint. Another time I had called the RCMP about the noise because it was after 11pm. They did come down but didn't think there was anything that could be done. I gave up but here we are again.

How is this permitted in a residential area.

LNG Canada Response To Public Concerns – Minette Bay Project South

LNG Canada is required by federal and provincial permits to build effective saltmarsh habitat offsets in Minette Bay. Between 2019 and 2022, this work was done by an EPC contractor on behalf of LNG Canada.

LNG Canada has since identified that the Minette Bay South saltmarsh has issues requiring repairs to make it effective and will be self-performing that work. Local stakeholder engagement began in 2024, and at that time LNG Canada was made aware of concerns raised by an adjacent landowner to one of the work areas during the original construction via the LNG Canada Community Feedback Process.

LNG Canada Corporate Relations has been in regular contact with that adjacent landowner to understand and mitigate their concerns. This engagement includes:

- Multiple communications per month since September 2024 via e-mail and phone. The relevant content of these engagements has included:
 - Historic experience with the saltmarsh construction activities and noise
 - Updates on planned activities and timing
 - Concerns about potential disturbance from the upcoming and future activities
 - Compensation for disturbance
 - Coordination of noise monitoring for the upcoming activities
- Meetings in person on September 27 and November 6, 2024, with Corporate Relations and Construction representatives of the project to understand the concerns and provide information on the planned upcoming work
- Notifying the landowner of the District of Kitimat's Public Notice and comment period regarding access to the Minette Bay property on March 31, 2025

LNG Canada's understanding is that the primary concern of that adjacent landowner is noise disturbance from construction activities. To mitigate that potential impact, LNG Canada has committed to the following actions:

- Continued engagement with that adjacent landowner during construction activities to maintain an understanding of their experience of the potential disturbance
- Conducting noise monitoring on the property during construction activities to better understand the potential disturbance. Baseline measurements have already been collected
- Restricting construction activities to adhere to the District of Kitimat bylaws related to noise. More specifically:

- Hauling material to be stockpiled at the laydown is planned to occur between 7:00am and 6:00pm, for a duration of 3 weeks starting when access is granted
 - Moving material from the laydown stockpile to the marsh must occur during low tide. LNG Canada's contractor plans to work during one tidal cycle per day, for a duration of 8-9 hours. As the tidal cycle shifts each day, so will the working hours, however the noise-generating work will be stopped between 10:00pm and 6:00am when the low tide overlaps with these hours. The duration of this activity is expected to be approximately 2 months beginning on May 1
 - LNG Canada will additionally commit to providing an estimated forecast of working hours for information
- Ensuring equipment noise reduction technologies (e.g. mufflers) are maintained and in proper working order
 - Not routing truck traffic through Strawberry Meadows wherever possible
 - Using rubber-wheeled vs. steel-tracked equipment where practicable; and
 - Shutting down equipment when not in use and minimizing idling time where possible

LNG Canada will continue to work with the adjacent landowner throughout the execution of the Minette Bay South project.

Background:

Nation2Nation creates a forum for conversations between First Nations, government, industry and women leaders. This year, Nation2Nation has chosen Kitimat for its annual Women's Gathering (April 23-25) and annual Forum (October 21-23). The organizer plans to use Riverlodge during both events and has indicated an openness to collaborate with the District for the events including Council participation in the opening ceremonies.

Staff will present a report regarding sponsorship for the Annual Forum in October at a future meeting for Council consideration.
