<b>Request</b>	Form B8 - Professional Liability states “single project group professional liability insurance” suggests that we need a \$5M policy solely for this project. Is it acceptable to complete the Form B8 without the ‘single project’ coverage?
<b>Response</b>	No. Form B8 - Professional Liability requires project specific Professional Liability insurance with minimum limits of \$5 million per occurrence and \$10 million aggregate for the Haisla Bridge Replacement Project.
