37 YEARS RESIDENT OF KITIMAT

I HAVE OWNED LOT #2 IN PHASE #1 STRAWBERRY MEADOWS FOR NEARLY 20 YEARS.

I AM AGAINST RE-ZONING OF #461 QUATSINO BLVD.

THIS IS AFFECTING MY MENTAL HEALTH AND MY MENTAL ILLNESS, I AM SCARED.

I AM AS, LINDA SLANINA STATES, "THE NEIGHBOURS"

THE SLANDER AND ACCUSATIONS ARE VERY DAMAGING, MISLEADING AND HARD MENTALLY FOR ME TO DEAL WITH. MY SAFETY HAS BEEN COMPROMISED.

21 YEARS AGO I PERSONALLY HAD TO USE THE SERVICE FOR ABUSED WOMEN. IT WAS MY G.P. THAT PUT ME THERE.

BROKEN RIBS, WITH A CHILD AND HOMELESS. WHERE WAS I GOING TO GO? MAYOR R.WOZNEY WAS IN COURT AND HEARD ABOUT THE VIOLENCE. MENTALLY THAT WAS VERY HARD TO HAVE YOUR PRIVATE LIFE AIRED PUBLICLY IN COURT.

THIS IS WHERE JACK OVIATT COMES IN. AS A BROKEN WOMEN WITH A CHILD I NEEDED A SAFE, VIOLENCE FREE HOME. MY SON AND MYSELF DESERVED TO BE SAFE IN A HOME WHERE WE DO NOT GET THROWN OUT OF AFTER THE BEATINGS. JACK OVIATT SHOWED ME, HELPED ME, THEN GAVE ME THE PROPER DIRECTION TO GO WITH DEVELOPMENT. I TOOK THAT CHANCE TO INVEST INTO OVIATT'S NEIGHBOURHOOD 20 YEARS AGO IN 2000.

MAYOR R. WOZNEY DID THE LEGAL PAPERWORK FOR MY LITTLE SANCTUARY TO BE. A HOME WITH PRIVACY, WHERE I WILL NOT BE BEAT IN. A HOME MY CHILD COULD BE SAFE AND SECURE. I HAD TO WORK SO HARD TO PROVIDE THAT TYPE OF QUALITY FOR MY SON.

COUNCILMAN GOFFINY WAS MY SON'S ELEMENTARY TEACHER. COUNCILMAN M.ZILIZKEY WAS OUR FIREMAN AND PROBABLY BE LABELLED THAT HERE IN KITIMAT ALWAYS, SORRY MARK. MR.MAYOR GURMUTH WAS MY MECHANIC IN THE 90S AND MY FRIEND SINCE THE 80S. COUNCIL LADY L.CAMPBELL HAS KNOW ME SINCE I WAS 15 AND PREGNANT. COUNCIL LADY LANIE DID MY WILL BACK IN AROUND 2008 ?

I TAPED MY BROKEN RIBS AND MY BROKEN HEART TO ESTABLISH THAT SAFE, VIOLENCE FREE HOME FOR MY SON. MY CHURCH BOUGHT INTO JACK OVIATT'S DREAM NEIGHBOURHOOD. THE OLD CHURCH BECAME AVAILABLE UP THE HILL, THEY NOW DID NOT NEED A CHURCH BUT WANTED A SAFE HOUSING FACILITY FOR MEN, WOMEN, CHILDREN, ANYONE WHO NEEDED HELP. MY PASTOR WANTED TO HELP WOMEN IN NEED LIKE I JUST EXPERIENCED. THE CHURCH WAS DENIED AND TOLD THE ZONING COULD NOT BE CHANGED.

I TRIED TO PURCHASE #461 QUATSINO BUT THE ZONING DID NOT ALLOW RESIDENTIAL.

THE CITY PLANNER SAID #461 QUATSINO WAS NO LONGER AVAILABLE BECAUSE IT WAS NOW A GREEN BELT. TO THIS DATE I HAVE NO KNOWLEDGE WHEN #461 QUATSINO WAS DEEMED A GREEN BELT.

I WORK 96 OR MORE HOURS IN 2 WEEKS. I WASN'T NOTIFIED BUT THOUGHT I HAD MISSED AN ANNOUNCEMENT.

CHALK UP ANOTHER, WHEN I RETIRE I WILL BE ABLE TO ENJOY MY PROPERTY. I WILL NOT MISS MEETINGS WHEN I RETIRE.

NOVEMBER 30, 2014

2 FIRE HYDRANTS FAILED AND FIRE TOOK EVERYTHING, MY FUR BABIES TOO. DUE TO FIRE, NO PHONE, NO VEHICLE, NO CLOTHES, NO HEAT, NO CLEAN WATER. I COULDN'T EVEN FIND A HOTEL ROOM. I KNOW FIRST HAND KITIMAT AND AREA NEEDS A SAFE PLACE FOR ALL.

FROM DECEMBER 2014 TO THIS DAY I AM STILL TRYING TO RECOVER FROM THIS HORRIFIC TRAUMATIC EVENT IN MY LIFE. HARDEST THING TO EVER WATCH - EVERYTHING YOU HAVE WORKED SO HARD FOR AND 2 HEARTBEATS GO UP IN FLAMES.

I WAS PICKED UP OUT OF THE SNOW AND TAKEN AWAY IN AN AMBULANCE.

FIRE HOSES EVERYWHERE BUT WHERE WERE MY BABIES, MY HEARTBEATS, MY BEST FRIENDS, WHERE ARE THEY?

LOOKING OUT THE AMBULANCE WINDOW I KNEW TO TAKE A GOOD LOOK AS I WOULD NEVER SEE ANY OF IT AGAIN.

THEY WASHED THE BLOOD OFF MY BODY, STITCHED ME UP AND SENT ME ON MY WAY WITH MY TORN BLOODY CLOTHES. THERE WAS NO PLACE TO GO, NOT EVEN A HOTEL ROOM. THE PROVINCE HELPED ME, SOME RESIDENTS ALSO DONATED, THIS HAPPENED DURING KMP. I WAS SCARED IN SHOCK AND VERY VERY COLD. I DIDN'T HAVE A VEHICLE, PHONE, CLOTHING OR FOOTWEAR.

WHERE WAS TSW THEN?

I MUST HAVE HAD AN INCOME THAT DOESN'T QUALIFY ME FOR HELP?

I WALKED THROUGH SLUSH, SNOW, COLD FRIGHTENED AND IN SHOCK. I WAS SO MIXED UP. 2 MONTHS LATER JAN 28, 2015 I FINALLY RECEIVED A FURNISHED APARTMENT.

DURING MY TIME IN THE APARTMENT MY PARENT ENDED UP IN ICU IN A DIFFERENT PROVINCE ON LIFE SUPPORT IN AN INDUCED COMA.

I NEEDED TO GET THEM TO B.C. IN MY HOME. I WANTED TO BUILD A LEGAL SUITE.

PAID FOR DESIGNS, BLUE PRINTS, TRUSSES OUT OF POCKET, NO GRANTS OR GOVERNMENTAL ASSISTANCE.

D.O.K. SAID I COULD NOT SINCE LOT #2 IS NOT ZONED FOR SUCH USAGE.

IF I HAD KNOWN 20 YEARS AGO THAT THIS ATROCIOUS BUILDING WAS GOING TO BE MY VIEW FROM MY LIVING ROOM, DINING ROOM, FRONT COVERED DECK, I NEVER WOULD HAVE INVESTED IN JACK OVIATT'S DREAM OF BUILDING A COUNTRY LIVING NEIGHBOURHOOD.

THIS IS AFFECTING MY MENTAL HEALTH STRESS, FEAR, ANXIETY. I WILL ADD IF I KNEW IN 2015 THAT THIS RE-ZONING WAS TAKING PLACE I WOULD NEVER HAVE REBUILT HERE.

IM FEELING BULLIED , HARASSED AND THREATENED

I'M BARELY HANGING ONTO NOW. I HAVE NO FIGHT. I WILL LEAVE KITIMAT. THE HOUSE AND LOT ARE THE ONLY THINGS THAT I HAVE LEFT FROM ALL THOSE HARD YEARS OF SHIFT WORK OUTSIDE IN THE BITTER COLD.

IT TRULY SADDENS ME THAT I HAVE TO LEAVE. I WANTED TO RETIRE HERE IN MY NEIGHBOURHOOD. I DON'T SLEEP. I DON'T EAT. I'M SCARED FOR MY SAFETY AND THE SAFETY OF MY NEIGHBOURS MALE AND FEMALE. I FEAR FOR MY SON.

IM FEARFUL OF THE SLANDERING ABOUT "THE NEIGHBOUR"

I WILL NOT GET STARTED ABOUT THE SIDEWALK THAT GOES NOWHERE. THE SIDEWALK THAT STOPS ON CRANBERRY.

NOW JAYWALKERS COMING OUT WHO KNOWS, AND THE TRAFFIC FROM THE SOCCER FIELDS. THE DARK TREED AREA FROM BERRY TO THE DELTA KING IS VERY WORRISOME WITH ALL THE STRANGER PEOPLE WALKING OUT OF BERRY. I HAVE COME VERY CLOSE TO BEING HIT BY VEHICLES COMING ACROSS FROM THE STOP SIGN. NOT A SAFE THOUGHT OUT PLAN !! WE ALL KNOW ITS FOR THE 14.5 METER BUILDS OCCUPIES. I KNOW FIRST HAND HOW, WHAT AND WHY I AN ABUSED WOMAN FEARS! I KNOW WHAT MADE ME FEEL SECURE AND SAFE.
